Mark Bailey Sr. reviewed the JPOFFHIT cost analysis. YTD funding was \$9,711,398 vs expenses of \$8,983,989. We continue to monitor high cost claims and work toward options for providing Rx to those members through alternate channels.

Travis Cummings addressed HR vs benefit responsibilities and fully transitioning payroll to JPOFFHIT. Elana Fowler will continue to monitor payroll adjustments as Amy completes training. Recent adjustments have been withing the expected range of occurrences.

John Keane inquired about compliance with Federal reporting requirements. Sabrina advised JPOFFHIT is exempt.

John Keane inquired about CAA form 204 filing. Teresa advised she would verify filing compliance and report back to the Board.
