Executive Director Report

Randy Reaves recognized Randy Wyse for a report. Randy Wyse informed the Board that the FRS members who's premiums are collected by JPOFFHIT and directed to the State were not properly deducted for a part of 2022 and for plan year 2023. Randy Wyse is working with members for reclamation. Payroll was corrected and current deductions are processing as expected.

Randy Wyse updated the Board with investment returns for 2024. Portfolio performances were as follows:
