Call to Order

Executive Director Report

Randy Reaves recognized Randy Wyse for the executive director's report. Randy Wyse updated the board on the upcoming open enrollment noting that virtual visit slots for 1 on 1 assistance were quickly filling up.

The meeting with JFRD Chief was pushed to November. Will likely have an update at the following meeting.

Randy W. remind the board the Chuze Fitness discount was approved, but member would need to notify their respective location for the account change. Chuze does not have a mechanism to verify JPOFFHIT membership on a bulk basis.

The Bailey Group- JPOFFHIT monthly review

Teresa Anderson reiterated that the 1 on 1 virtual enrollment sessions were limited do to demand. She also mentioned that request for 1 on 1 Medicare assistance was quickly filling up. Teresa advised the call center received approximately 20 calls referencing rate changes. Since the posting of rates on the JPOFFHIT website in preparation for open enrollment there have been no further calls.

Unfinished Business

Randy Wyse requested the board take action on the RFP for a claims audit. Randy W. and staff from the Bailey Group met with both BMI and WellRithms to review the proposed level of service offered. Randy recommended BMI.

John Keane made a motion to enter into a contract with BMI to perform the claims audit. Kelly Dobson seconded the motion. Randy Reaves called the vote and the motion passed unanimously.
